Previously Opening Permission has been accorded to the classes VI to X of Viswabharathi Wisewoods (EM) High School, Vanapamula, Pedaparupudi (M), Krishna District during the year 2016-2017 in proceedings L.Dis.No.569/A1/2016, Dated.17.06.2016 of the Regional Joint Director of School Education, Kakinada in the reference 5<sup>th</sup> read above. The Correspondent has submitted the application for Provisional Recognition for the classes VI to X (EM) in the school for the years from 2016-2017 to 2025-2026 in the reference 6<sup>th</sup> read above. The District Educational Officer, Krishna, Machilipatnam has verified the application for Provisional Recognition with reference to the inspection Report of the Inspecting Officer and G.O.Ms.No.1 Education, Dated.01.01.1994.

Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada the competent authority for Secondary Schools hereby accords Provisional Recognition for a period of 10 (Ten) years i.e. for the academic years from 2016-2017 to 2025-2026 for the classes VI to X (EM) as recommended by the Deputy Educational Officer, Gudivada and District Educational Officer, Krishna, Machilipatnam in respect of Viswabharathi Wisewoods (EM) High School, Vanapamula, Pedaparupudi (M), Krishna District without GIA now or in future subject to fulfillment of the following conditions.

1. That the society shall abide by the instructions / rules and regulations made by the Government or authorized officer from the time to time.
2. That the Educational institutions shall serve the needs of the locality more particularly.
3. That the Educational institutions shall adopt the curriculum and syllabus prescribed by the Government from time to time.
4. That the institution shall follow the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September at least.
8. That the list of Governing Body shall be furnished to the District Educational Officer every year.
9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
13. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expiry of the present recognition.
14. That the society shall provide fire safety measures in the school as per the No Objection Certificate. The same should be got renewed for the entire period of recognition.
15. The management informed that no thatched roof accommodation is allowed to run the school.
16. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students.
17. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
18. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
19. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
20. The school shall have first aid kit and the teachers shall be trained in first aid.

22. That the management has to maintain trained teachers at all times.
23. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated 03.08.2009 regarding Fee Structure in Private Schools.
24. That the management shall ensure the Accountants of the school audited by an authorized Chartered Accountant every year and submit before 30<sup>th</sup> September along with school Administrative report.
25. The Correspondent shall file an affidavit before April 30<sup>th</sup> of every year to the effect and there shall be no deviation or violation of norms prescribed by the Government from time to time.
26. That the Recognition now granted is subject to genuineness of the Fire NDC from the concerned competent authority.
27. That the Management of the school shall obtain the Occupancy Clearance from the Fire Services Department concerned for the entire period of recognition and submit the same to this office without fail.

If the management fails to comply with the above conditions promptly, the Renewal of Recognition now granted will be reviewed for necessary action as per rules.





